Finding the Positives in our "New Normal"

As I write this, we are about 8 months into the COVID pandemic. It seems that we still learn something new about it every week – some good news, some bad. But for the most part people have settled into a new normal while eagerly awaiting the return of the old normal.

Economically, most Legends Bank markets are on the upswing. Unemployment numbers, while still much higher than they were at the beginning of 2020, are better than the early days of the pandemic when stay at home orders were in place. Most local businesses, including in the personal services and hospitality sectors, have reopened. Some are not yet at full capacity because of health department guidelines, but generally the trend has been toward fewer restrictions. To the surprise of many, most schools have been able to return to in person instruction though under much different rules than were in place a year ago.

While some local businesses are still not out of the woods financially, many were assisted by Payroll Protection Program loans. We feel fortunate that we were able to assist over 250 businesses with these loans, totaling over \$10 million. Of course, these businesses cannot survive over the long term without the patronage of their local customers. I have heard more than a few heartwarming stories from these business owners of the extraordinary support they have received even when they were not able to provide their full complement of goods or services. What a wonderful testament to the spirit of the communities in which we live.

We at Legends Bank are humbled at the trust our customers have shown in us since the pandemic began. Deposits have flooded in, causing us to grow roughly 10% (over \$40 million) in the six-month period beginning March 1. To my knowledge the bank has never in its history experienced that kind of organic growth in such a short period of


time. We take seriously our responsibility to both safekeep our depositor's funds and to use our resources to assist our customers during these difficult times.

According to the latest travel data from the September 2020 American express Trendex Study, travelers still say the ability to see the world is critical to their happiness and is important to keep friendships and family relationships intact despite the coronavirus pandemic.

Our Pay Someone product lets you pay a friend, family member or even a babysitter electronically even if you don't know their bank account number. You just need an email address or mobile number.

YOU CAN USE TO:

- Send money to your child at college.
- Pay your babysitter or lawn care service.
- Contribute money to a group dinner or gift.

FEATURES

The money you send and receive using Pay Someone ultimately transfers from bank account to bank account, and offers a convenient alternative to cash and checks.



HERE'S HOW IT WORKS...



Log in to Mobile Banking or your Legends Online Banking Account. Click the Pay Someone link."



Enter Payment Information.



Recipient receives email or text notification with instructions.



Your payment is securely deposited directly into recipient's bank account.

*Requires an active Legends Bank Debit Card. You pay just \$0.50 for each Pay Someone transaction sent.

*Note: You may be asked to verify confidential information if you call your bank, but rarely the other way around. If you're ever in doubt that a bank call is legitimate, or if a caller pressures you to stay on the line and provide bank information right away or something bad will happen, it is a scam. Hang up and call the number on the back of your card to talk to a real bank employee.



What Is a Will?

A last will and testament is a legal document that lets you direct how your property will be dispersed (among other things) when you die. It becomes effective only after your death. It also allows you to name a personal representative (executor) as the legal representative who will carry out your wishes.

What Is a Trust?

A trust is a legal relationship in which you, the grantor or trustor, set up a trust, which holds property managed by a trustee for the benefit of another, the beneficiary. A revocable living trust is the type of trust used most often as part of a basic estate plan. "Revocable" means var can make changes to the trust or even revoke it at any time.

A living trust is created while you're living and takes effect immediately. You or ownership of assets, such as a house, boat, automobile, jewelry, or investmy You can add assets to the trust and remove assets thereafter.

How Do They Compare?

While both a will and a revocable living trust enable you to direct the distrib assets and property to your beneficiaries at your death, there are several differenthese documents. Here are some important ones.

- 1. A will generally requires probate, which is a public process that may be time-consuming and expensive. A trust may avoid the probate process.
- 2. A will can only control the disposition of assets that you own at your death, including property you held as tenancy in common. Different Documents, Different Features. Even if you have a revocable living trust, you should have a will to control assets not captured in the trust.


Depends on applicable state laws.

It cannot govern the distribution of assets that pass directly to a beneficiary by contract (such as life insurance, annuities, and employer retirement plans) or by law (such as property held in joint tenancy).

- 3. Your revocable trust can only control the distribution of assets held by the trust. This means you must transfer assets to your revocable trust while you're living.
- 4. Unlike a will, a trust may be used to manage your financial affairs if you become incapacitated.
- 5. If you own real estate or hold property in more than one state, your will would have to be filed for probate in each state where you own property or assets. Generally, this is not necessary with a revocable living trust.
- 6. A trust can be used to manage and administer assets you leave to minor children or dependents after your death.
- 7. In a will, you can name a guardian for minor children or dependents, which you cannot do with a trust.

Generally, most estate plans that use a revocable trust also include a will to handle the distribution of assets not included in the trust and to name a guardian for minor children. In any case, there are costs and expenses associated with the creation and ongoing maintenance of these documents. Keep in mind that wills and trusts are legal documents generally governed by state law, which may differ from one state to the next. You should consider the counsel of an experienced estate planning professional and your legal and tax advisers before implementing a trust strategy.

Wills and trusts are common documents used in estate planning. While each can help in the distribution of assets at death, there are important differences between the two.
