# DAY 5 | Case IH Factory Tour | SC Johnson Plant Tour | Wind Point Lighthouse (B,D)

Get a behind-the-scenes look at how the red Case IH Magnum Series tractors are built. See a tractor being built from the ground up! Then on to the SC Johnson Plant to see how this family-owned company is a leader in the manufacturing of household cleaners, air care products, shoe care products, pest control, & more. Learn about the long-held friendship between the SC Johnson Company & the architect, Frank Lloyd Wright. Their corporate office building, a Frank Lloyd Wright architecture style, built-in 1939, is a top 25 building of the 20th century. The Wind Point Lighthouse stands at 108 feet tall and is listed on the National Register of Historic Places. Its light has been shining for 140 years over Lake Michigan.
