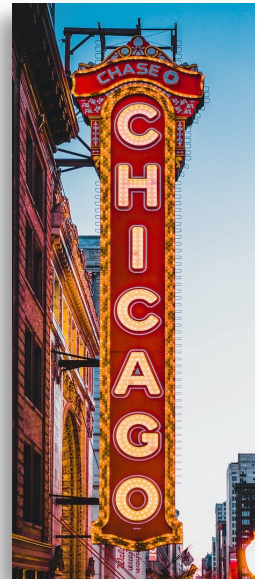
Wednesday, June 12 (Dinner)

This morning we board our motorcoach headed for the “Windy City” with comfort stops along the way. Upon arrival in **Chicago**, we’ll make our way downtown to check into the 4-star **Palmer House Hilton** for three nights. This hotel has a rich 150-year history as the first hotel to incorporate the light bulb, telephone, and elevator. Nearly every sitting U.S. President since the 1870s has spent the night here. It also served as the original home of the brownie, which was invented at the hotel for the World’s Columbian Exposition in 1893. You’ll have time to unwind before we depart for **dinner** together at a local restaurant.

Thursday, June 13 (Breakfast, Dinner)

Breakfast is included at the hotel’s **Lockwood Restaurant** before we depart to take in the sights and sounds of Chicago on our **guided city tour**, detailing features from its magnificent city skyline stretching across 22 miles of the massive freshwater Lake Michigan. We’ll see famous locations such as **Millennium Park, Grant Park, Willis (Sears) Tower**, the **Magnificent Mile**, and **Lake Shore Drive** as our guide shares interesting stories about Chicago’s past and present. Our tour will end at **Navy Pier**, where there will be time to have lunch and shop.

This afternoon, we’ll experience Chicago from a unique perspective during our **Chicago Architecture Foundation River Cruise** - a must-see for visitors and Chicagoans alike. Certified tour guides will interpret more than 50 buildings along the Chicago River. You’ll find out how Chicago grew from a small settlement into one of the world’s largest cities in less than 100 years as you hear the true story on Chicago architecture and its history. After the tour, we’ll head back to the hotel to freshen up. Enjoy dinner together this evening at **Lou Malnati’s Pizza**, where we can try out Chicago’s famous deep dish pizza. For an exciting finish to the day, we’ll take our seats at the theatre for this evening’s performance of a **Broadway in Chicago play!**



Friday, June 14 (Breakfast)

Wear your Cardinals red today!

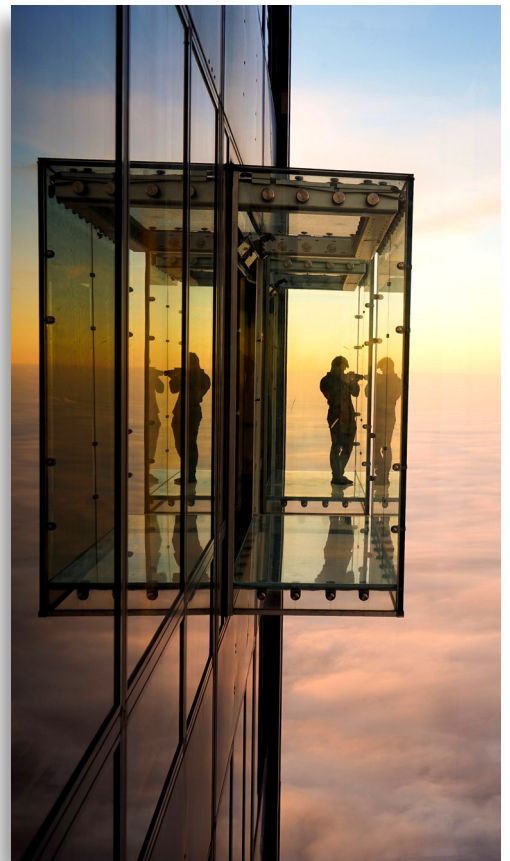
Enjoy breakfast in the Lockwood Restaurant before we depart for Chicago's **Field Museum of Natural History** for a morning of inspired curiosity and scientific exploration. Stretch your legs and explore one of the world's leading natural history museums, with more than 40 million artifacts in its collection. Then we head to **Wrigley field** to take our seats for an exciting summer baseball game as we **watch the Cardinals battle the Cubs**. You may want to try a Chicago-style hot dog, and you'll definitely want to proudly wear your red as we cheer on our favorite team! After the game, we'll make our way to one of Chicago's most famous districts - the **Magnificent Mile** on Michigan Avenue! Take time to stop in one of the hundreds of shops and restaurants along this stretch, with iconic brands at practically every corner. You will also find many dining options in and around our hotel.

Saturday, June 15 (Breakfast, Lunch)

Today we'll enjoy our last breakfast before departing for the **Willis (Sears) Tower**. We'll travel up to the 103rd floor where you have the option to take a stomach-dropping step out onto the **Skydeck**, a glass-enclosed ledge 1,353 feet up in the air! Roam through the in-house museum that highlights the building's rich history before witnessing incredible views of Chicago from the highest public observation deck in the United States.

We'll enjoy **lunch** together at a local eatery before we start making our way back home. Sit back, relax, and reminisce about your wonderful trip. You're sure to return home with a better understanding of why the Chicago natives say, "It's my kind of town!"
