TUESDAY, APRIL 21 (Kickback Reception)

This afternoon we'll transfer to the **Drury Inn** at the St. Louis Airport. Enjoy the hotel's **Kickback Reception** with hot food and cold drinks.

WEDNESDAY, APRIL 22 (Breakfast, Dinner)

This morning we'll take a flight to **Seattle, Washington**. Upon arrival we will board our deluxe motor coach and head north toward the San Juan Islands. Our destination is **La Conner, Washington** where we will check into the charming **La Conner Inn** for two nights. We'll have some time to enjoy this quaint town before gathering for dinner at a local restaurant.

THURSDAY, APRIL 23 (Breakfast, Lunch)

After breakfast at the hotel, we will be welcomed aboard San Juan Cruises' *Victoria Star II*, a splendid private motor yacht, for an **exclusive day cruise** through the magnificent **San Juan Islands**. These beautiful islands are located off the scenic Pacific Northwest Coast, north of Seattle. Our cruise route will take us through the beautiful **Swinomish Channel**, then north along the **Saratoga Passage** where we will pass under the **Deception Pass Bridge**, one of the most photographed landmarks in Washington State. On our cruise, we'll be watching for the wide variety of wildlife that inhabit the area including Orca, Humpback and Minke whales, bald eagles, harbor seals, Dall's porpoise and sea birds. As we reach the charming and historic seaport town of **Friday Harbor**, we will disembark for a 2-hour port call. Explore, shop, visit art galleries, and take in the views before returning to the *Victoria Star* to continue our exploration.


Enjoy an old-fashioned **Dungeness Cracked Crab lunch** on board while we continue to watch for wildlife, and as our captain gives us interesting and entertaining narration on the history, geology and wildlife of the islands. Late afternoon, after bidding farewell to our Captain and crew, we'll have the rest of the evening free to explore La Conner. There is a wide variety of restaurants from which to choose.

FRIDAY, APRIL 24 (Breakfast)

This morning we explore **Skagit Valley**, a picturesque area nestled between the Cascade Mountains and the Salish Sea known for its tulips, orchards, and quaint communities. Experience highlights of the **Skagit Valley Tulip Festival** as we visit **Tulip Town**, a 30-acre farm offering a variety of display gardens including an International Peace Garden and a stunning 10-acre field planted in stripes of color. Take a **trolley ride** around the fields - a great way to get an elevated panoramic view.









There's also an indoor flower and garden display. Our next stop is **RoozenGaarde**, the largest tulip farm in the United States with its 30-acre field of tulips. We'll explore their beautiful 4-acre garden, featuring more than 250,000 bulbs and an authentic Dutch windmill. We'll then make our way south toward Seattle, making a stop at **Snohomish**, a town listed on the National Registry of Historic Places and known as the "Antique Capital of the Northwest." Enjoy strolling among the town's late 19th Century architecture and stopping at the delightful variety of shops and popular restaurants.

As we make our way to Seattle, we will visit the oldest winery in Washington state, the **Chateau Ste. Michelle**. Their rich history of innovation and winemaking tradition is only surpassed by their famous Rieslings, which you can enjoy during our afternoon wine tasting. Upon arrival in Seattle, we'll check into the **Sheraton Seattle Grand Hotel** for two nights. Enjoy a free evening in the Emerald City! Our hotel is located within walking distance of many restaurants and some of Seattle's best attractions.

SATURDAY, APRIL 25 (Breakfast, Dinner)

After breakfast, we will board our deluxe motor coach with our **local guide** who will join us for a **Seattle City Tour**. Highlights include the floating homes, Pioneer Square and so much more! Later this morning we'll make our way just outside Seattle to **Snoqualmie Falls**. This awe-inspiring 270-foot waterfall is one of Washington's most popular scenic attractions.

Next we head back into the city for an exciting afternoon in downtown Seattle. We first head to the world-famous **Pike Place Market**, where you'll have free time to explore, shop, and have lunch at one of the many restaurants. After lunch, we will be amazed by the stunning works of art, created by world-renowned glass artist, Dale Chihuly, at **Chihuly Garden and Glass**. The centerpiece of Chihuly Garden and Glass is the Glasshouse, a 40-foot tall, glass and steel structure covering 4,500 square feet of light-filled space. Within its walls is an expansive 100-foot-long sculpture in a color palette of reds, oranges, yellows, and amber. It is one of Chihuly's largest suspended sculptures. In the adjacent gardens is a unique plant collection specially chosen to complement more of Chihuly's artwork. We'll also get panoramic city views from 520 feet above Seattle at the top of the iconic **Space Needle!** We'll gather this evening for a farewell dinner at a popular Seattle restaurant.

SUNDAY, APRIL 26 (Breakfast)

After breakfast we're off to the airport for our flight home. We'll be taking with us enchanting memories of a fantastic trip to Sensational Washington!
